#### **Minutes**

Minutes from the 4.9.20 building committee meeting were approved by the building committee members present, with the exception of Angus Jennings, who abstained.

#### **New Business**

### A. Schedule Update -

The schedule and permitting process continue to progress without delay. Our next MSBA submission is on the agenda for approval this evening, CD 90%. WN Planning board has finished and we are now working with the Groveland Planning board, their next meeting is May 5th. WN Conservation has finished and they issued a draft of their order of conditions. The interiors subcommittee will meet once more and then report out to the entire committee at the next building committee meeting.

## B. Commissioning Monitoring Proposal -

The MSBA pays for the commissioning process which occurs during the construction phase of the project. This item is a preventative maintenance plan to monitor, adjust and repair systems in real time in the years following the completion of the project. The cost is \$14,000 and will come from the Owner's contingency. This item was approved by a unanimous vote.

### C. Materials Testing Proposal -

The project has budgeted \$150,000 for materials testing. Vertex put the testing out for 3 bids and Fenagh came in as lowest. They have a good reputation and Vertex has worked with them on other jobs. The OPM is requesting a \$50,000 purchase order for the first phase of materials testing. This request was unanimously approved.

- **D. ERP Status** There is good news on the ERP packages. At our last meeting we approved moving forward with the first set of ERP not to exceed \$31,626,270 and after shifting one portion of the site work to the future landscape bid and improvements in final pricing, we came in at \$30.903,270. These prices will be carried in future estimating as actuals instead of estimates.
- **E. 90% CD Submission** The CD 90 set is ready for submission to MSBA. Last week the project team compared the 2 estimates created from 90CD and at this point we are slightly under budget at \$146,286,823 as compared to \$146,332,328. The committee unanimously approved the authorization for Vertex to submit these documents to the MSBA on April 28th.
